We moved as a family of three down from Wisconsin summer of June '22 for healing not expecting any drama especially from the coaching staff. We experienced the traumatizing loss of my husband/Dad within a year of moving.

Naomi was at a state cross country meet in Wisconsin and had just finished her meet as I got the phone call from a sheriff that her dad had committed suicide.

She is dealing with flashbacks and her running this past year here at Arnold High school with XC is a great accomplishment.

She was always encouraged by the previous coaching staff, fellow athletes. She thrived being with the team. Naomi is more of a sprinter and a basketball player than a long distance runner, but enjoys the camaraderie and conditioning offered by XC.

Regina called in the summer to ask why Naomi wasn't attending the (optional) summer practices. Naomi had attended two optional summer practices.

I told Regina she wasn't as motivated and grieving the loss of her dad. She was adjusting to the heat, as we had just spent three weeks in Wisconsin in the early summer. Additionally she had started a job at Captain Anderson which required her time. And lastly, her friend Maddie, had not been at the optional practices, as she was practicing with Coach Tom. Regina mentioned to me that Maddie not being coached in the summer by the Merritt's was not good for the team.

Fish camp day, August 8, 2023 when Naomi returned home and Maddie came over later, Maddie brought up a situation that occurred at practice that traumatized Naomi. Then the girls went on to tell me that Frank Merritt called her out during the group meeting. He said she was out of shape and slow. He directly addressed her and said for the whole team to look at her, that she would not make the team time because she was out of shape in his opinion. Naomi felt humiliated and shamed standing in that circle. Naomi was very affected and upset, but begged me not to say anything to the coaches because she was scared that they would retaliate against her.

#### August 10th Thursday evening

Naomi was having issues with her hip and back, which locked up (now resolved via chiropractic aid). I messaged Regina re: Naomi is not to run, but can she be shown other exercises that might help her work through the hip/back issue. At this point, the Merritts had seen her run no more than 3 times this season. Naomi was at practice despite her injury on Friday August 11th.

Friday August 11 in the late morning, I received a call from the Merritts to discuss their concern for Naomi's health. They wanted her to avoid injury by taking a break from XC so she can play basketball. I told them how much the team has meant to Naomi in her journey of healing from recent traumas. Merrits said Maddie was injured and might very well be out for the rest of the season, if not a good part of it. I believe they said this as additional persuasion for her to quit the team. They said Naomi was in worse shape than she was last year. They told me although of course it's our decision to make, they think it's in Naomi's best interest to leave the cross country team. I felt pressured by the medical advice Frank was influencing me and therefore I agreed to listen to their advice because Regina offered to talk with Naomi and I. When I told Naomi about the call, she broke down in tears because she did not want to leave the team. When we called Regina, Her first question was "what are your thoughts on cross country?" Naomi responded by telling her that she was not a big fan of it but she loved being part of the team. She was not very engaged, responding with "Yes ma'am", "No ma'am",

submitting and numb from being upset. Regina said "you don't have to feel bad about it, we're going to refund your mom her \$250". Naomi never had a chance to speak up and say she wanted to remain on the team during that phone call but was forced to quit.

That Friday Naomi went with the Nichols to a lake house for the weekend. After her return I found out there were several other families in similar situations.

August 17th Naomi and I had a meeting with Mr Green and Mr Smith about what was taking place on the XC Team and how it affected my daughter. Naomi also shared with them how she was made to feel. In that meeting Mr Green stated that Naomi was allowed to come back on the team anytime. He made that decision himself during the meeting without coach approval. Before I left that meeting I made it clear that I don't trust Frank after what he did to Naomi and don't want him near her. Mr Green then asked us at that time to meet with him and the Merritt's which Naomi and I agreed to.

On August 21 I received a text which was sent to both Naomi and Coach Green as well from Regina saying Naomi was welcome to come back but gave a time limit of 8pm to respond. Text is attached.

On August 24th I went to school and took Jordan Nichols for support into the meeting. The coaches all tried to intimidate me by having a group of people including all the volunteer coaches present that are parents of other athletes. There was Coach Green, Regina, Frank, Julio and Stacey Flores all present in the meeting room. I had been told this meeting was with the Meritts and Coach Green only so I asked for the extra people to leave. Instead they wanted my support person Jordan Nichols to leave but I had already arranged permission to have him there by Mr. Smith. This upset them all but they finally left when Coach Green asked them to.

As soon as the meeting began, Regina started talking about how much they love Naomi and of course Naomi could stay on the team. I let her finish talking, but saw no point in the meeting after that. So I told Frank to stay away from my daughter and told him "may God have mercy on you". And I walked out. There was no bizarre behavior except Regina got loud and jumped up saying I could not leave, which was witnessed by Jordan Nichols.

Later that evening I received a horrible harassing and insensitive email from Regina. I'm shocked by the behavior of a bay district school employee that is supposed to look after our children. Also besides being a horrific letter, the accusations in it were inaccurate. Email is attached.


The email response I received from Steve Moss clearly states that Regina wants no contact with me or my daughter and also none between us and her sons. He states that Naomi will not be on the Track team. Naomi being a student with great standing with all teachers and coaches has every right as a student of Arnold to be on the Track team so does this mean since Regina does not want contact with her that she will not be the Track Coach? Or is he saying Naomi will not be allowed on the Track team which is clear discrimination?

Naomi has been so traumatized by all of this that now she is even scared to walk into the gym hall in the morning. She is afraid to see or be confronted by them or have any interactions with them. She used to leave her basketball bag which she needs for her 7th period class in her gym locker, but due to fear of running into the Merritts she now carries two heavy backpacks with her all day instead. Naomi is still traumatized and grieving the loss of her dad and with this added

stress her academics are being affected. Even her math teacher has noticed it and spoken to me.
